A Special Message from the Director of Energy Safety

I write to draw the attention of licensed electrical contractors, electrical licensees and gas fitters to the Decision Regulation Impact Statements (D-RISs) released recently by the Council of Australian Government's National Occupational Licensing Steering Committee. They concern the proposed National Occupational Licensing System (NOLS).

Consultation RISs (C-RISs) were issued during 2012 which set out the proposals for uniform national occupational licensing schemes for electrical contractors, electricians, electrical fitters, restricted electrical licences and gas fitter licences. EnergySafety held consultation meetings with licensees in Perth and major regional centres during September 2012 to explain the proposed new scheme and to encourage those affected to respond with their comments. Over 300 written comments were received by the WA Government and more than 3,000 nationally.

After considering these comments, the Steering Committee has prepared the final D-RIS versions for the electrical and gasfitting occupations, which can be viewed at the National Occupational Licensing Authority (NOLA) web site [www.nola.gov.au].

EnergySafety has prepared the following summaries of the major changes made in the D-RISs. These are not the only changes and I encourage licence holders to read the appropriate D-RIS for themselves, both as a refresher about NOLS generally and to gain a complete picture of the changes made.

3	16	Nominees can be sub- contractors in some jurisdiction.	Following discussion between jurisdictions, it is also proposed that individual jurisdictions can choose to allow sub-contractors to fulfil the role of a nominee however, this arrangement may not be recognised outside the originating jurisdiction. A contractor who has a sub-contractor nominee and who enters into a contract for work outside the originating jurisdiction will be required to meet the nominee requirements in the jurisdiction in which the work is occurring.	Changed from C-RIS.
3	29	Electricians may need another licence to do fitting work	It is proposed that an electrician must also hold an electrical fitter's licence, in jurisdictions that regulate electrical fitting work. However, as many of the skills required for an electrician are similar to those of an electrical fitter, and a skill set should be developed by NOLA in consultation with industry and regulators, for a licensed electrician wishing to apply for electrical fitter licence. This would reduce the training impact by not requiring a person to complete an additional Certificate III or undergoing recognition of prior learning process.	This is a change from the C-RIS. Under this new proposal, electricians will not be allowed to do fitting work unless they hold both licences. This is a significant change since existing holders of electrician's licence are allowed to do fitting work.
3	39	Builders allowed to contract directly to electricians	The revised wording in the Amendment Bill makes clear that the holder of a non- electrical contractor licence, while exempted from holding an electrical contractor licence, must still contract with an electrical contractor, rather than the holder of an electrician or other electrical licence.	Builders will be required to go through electrical contractors. Changed from C-RIS.

The removal of training requirements for an electrical contractor's licence will have implications in WA. New electrical contractors will not have received any prior training on the additional safety and legislative requirements prior to being issued with a licence. No change from C-RIS.
3	46	On-the- job training requirements	Under national licensing, all experience requirements would be removed for all occupations. An apprentice electrician will not be required to undergo further on the job time, beyond that required as part of an apprenticeship, in order to be eligible for a licence	The highlighted words have been added. The question is how the apprenticeship will be managed i.e. will apprentices still be required to demonstrate they have completed enough on-the-job experience before they are allowed to sit the Capstone test and complete the apprenticeship. If not, this could open the door to purely classroom training.

The restricted electrical licence is granted automatically upon completion of their apprenticeship	Certificate III in Engineering-Mechanical Trade (Refrigeration and Airconditioning) is the only qualification that will gain a restricted electrical worker's licence in Western Australia, not the Certificate III in Electrotechnology, Refrigeration.
